Please join us on Thursday, January 5th, 7:00 pm at the Livonia Civic Center Library as we hear from a panel of city, township and county experts who will discuss revenue sharing and funding of local and county governments. The purpose of this event is to prepare our membership to participate in the LWVMI study on Government Finance. Panelists include Wayne County Commissioner (and former Michigan State Senator) Glenn Anderson, City of Wayne Mayor Susan Rowe, and Van Buren Township Trustee Sherry Frazier.

Our League's Government Finance Study Committee, chaired by Rosemary Doyle, will be meeting on December 3. The Committee is covering the material in depth, and will bring their proposed responses to the LWVMI consensus questions to the membership for approval at the February League meeting (date to be announced). If you are not part of the Committee, attending this forum is an excellent way to learn more about this issue so that you can participate fully in the consensus question decisions.

WHAT'S NEXT FOR PUBLIC TRANSIT?

As you all know by now, the regional transit funding ballot measure lost by a close 17,000 votes. Advocacy groups, like Transportation Riders United (TRU), put an enormous amount of effort into getting this proposal passed, and were naturally, terribly disappointed at the outcome. Said Megan Owens, Executive Director of TRU, "I am extraordinarily proud of the effort we undertook. The Regional Transit Authority (RTA) crafted a great plan that would have benefited so many people. Hundreds of organizations (like the League of Women Voters) and businesses came together to speak about the need for reliable regional transit. Yet ultimately, our efforts proved to not be enough, especially as our calls for compassion and bringing the region together were drowned out in an election of fear and anger at "others."

According to Owens, the RTA is committed to continuing its work to improve public transportation in the Detroit Metro Region, which is woefully lacking in basic public transit options for senior citizens, workers, the disabled, residents without cars, and tourists.

The problem has not disappeared, nor have the efforts for more and better transit. If you would like to stay connected to public transit advocacy, visit www.detroittransit.org. SHOUT OUT TO THE LEAGUE

In addition to all the candidate forums, voter guides and voter registration events that preceded the August primary, the NW Wayne County League was even more active prior to the general election.

Within a 3-week span in late September and early October, we held candidate forums for 11 more contests. At the end of my presentation, they had a mock presidential election and we took pictures. I expect great things from the girls in this group, and I look forward to attending their graduation next June




